

# Privacy Policy

Project 1882 could not exist without our supporters and donors. Therefore, it is important for us that every supporter and donor feel assured in our handling of their personal data.

Project 1882 works in accordance with the requirements of the EU Data Protection Regulation (GDPR).

Project 1882 collects and stores personal data with "legitimate interest" as a legal basis. It is in the interest of both the organisation and the supporter / donor that this data is saved. Read more about why we save personal data and how we use it under "Purpose".

## Handling of personal data

When you become a regular donor, give a donation, sign a petition, order materials or products or sign up as a volunteer, Project 1882 may save the personal information you provide. The information can be name, address, ID number, telephone number, e-mail address and for donations via direct debit also bank card or account number. We may also supplement/update your name, address, ID number and telephone number later on (information that is public).

We also save your interactions with Project 1882. This means that we save information about donating, signing a petition, subscription, course participation or ordering.

Project 1882 saves the information as long as you are a donor or have any other interaction with the organisation, then for 3 years. After that, the information is depersonalised, which means that all personal data is deleted.

Project 1882 never collects the following sensitive personal data: Religious / philosophical beliefs, political opinions, trade union membership, sexual life, nationality / ethnicity / race, health, biometric information or genetic data.

Project 1882 stores the information in designated systems that are protected by active security measures (such as firewalls). This is

documented and checked continuously by the organisation. Project 1882 never sell personal data to third parties.

We can share information with external parties who work on behalf of Project 1882. This is so that we can perform certain tasks, such as distribution or other services that maintain and apply our terms of use and delivery terms. However, in all handling of personal data, high security and confidentiality are always observed. Project 1882 undertakes to have valid personal data processing agreements with all suppliers who process personal data on behalf of Project 1882.

You can always contact Project 1882 to have your personal data completely or partially deleted.

### **Purpose**

We use personal data to develop and streamline Project 1882's work for the animals, develop Project 1882's websites and other services, provide good support to our donors / supporters / customers, be able to keep in touch with our donors / supporters / customers for service and fundraising purposes, and create (anonymised) statistics and analyses.
